President von Voigt called the meeting to order at 8:36 a.m. All the above-listed Commissioners were present at the start of the meeting with the exception of Commissioner Salimpour who arrived at 8:38 a.m.

A. ITEMS FOR BOARD ACTION

Item A.2 was taken out of order.

2. APPROVAL OF REQUEST FOR PROPOSAL FOR OUTSIDE INVESTMENT AND FIDUCIARY COUNSEL TO ASSIST THE CITY ATTORNEY IN REPRESENTING THE BOARD AND PLAN AND POSSIBLE BOARD ACTION

Mr. Alan Manning, Assistant City Attorney, discussed the request for proposal (RFP) process with the Board. Commissioner Navarro requested that the Board be involved in the interview process.

Commissioner Aliano made a motion to approve the RFP for outside investment and fiduciary counsel to assist the City Attorney in representing the Board and Plan and that the Board be informed of the finalists selected, who was involved in the request for proposal, and the criteria used in the selection process. He later withdrew his motion.

Commissioner Pendleton asked for clarification of the process and General Manager Ciranna explained the interview process utilized for previous RFPs. The Commissioners discussed the Board's interest in being more involved in the selection process.

RESOLUTION 16106

Commissioner Pendleton moved that the Board authorize the City Attorney's Office to issue a Request for Proposal to select outside investment and fiduciary counsel to assist the City Attorney in providing advice and representation to the Board and the Department of Fire and Police Pensions, and authorized the City Attorney and staff to prescreen the respondents and bring back to the Board a list of finalists to interview, which was seconded by Commissioner Nathanson and approved by the following vote: ayes, Commissioners Aliano, Diannitto, Nathanson, Navarro, Pendleton, Salimpour, Tapia, and President von Voigt – 8; nays, none.

Mr. Gregory Mack, Senior Management Analyst II, Manager of Communications and Active Member Services, presented the staff recommendations to the Board.

3. APPROVAL OF TRAVEL AUTHORITY (NAVARRO AND CIRANNA) – IAFF, 2016 ALFRED K. WHITEHEAD LEGISLATIVE CONFERENCE AND POSSIBLE BOARD ACTION

General Manager Ciranna stated the topics to be discussed at the conference.

Whitehead Legislative Conference on April 3–6, 2016 in Washington, DC (April 3rd is a travel day), which was seconded by Commissioner Nathanson and approved by the following vote: ayes, Commissioners Aliano, Diannitto, Nathanson, Navarro, Pendleton, Salimpour, Tapia, and President von Voigt – 8; nays, none.

4. FISCAL YEAR 2016-17 PROPOSED ANNUAL BUSINESS PLAN AND POSSIBLE BOARD ACTION

Ms. Diana Pointer, Senior Management Analyst, Administrative Services Section, presented the proposed Annual Business Plan to the Board. Commissioner Nathanson asked Mr. Tom Lopez, Chief Investment Officer, to provide the Board with a breakdown of local and sustainable investments. Commissioner Aliano thanked staff for all their hard work with the proposed Annual Business Plan.

RESOLUTION 16109

Commissioner Aliano moved that the Board approve the 2016-17 Proposed Business Plan, which was seconded by Commissioner Tapia and approved by the following vote: ayes, Commissioners Aliano, Diannitto, Nathanson, Navarro, Pendleton, Salimpour, Tapia, and President von Voigt – 8; nays, none.

5. FISCAL YEAR 2016-17 PROPOSED BUDGET AND POSSIBLE BOARD ACTION

Mr. Mark Granado, Senior Management Analyst I, and Ms. Carissa Takahashi, Management Assistant, Administrative Services Section, presented the Fiscal Year 2016-17 Proposed Budget to the Board. Commissioner Nathanson discussed management fees with Mr. Granado, General Manager Ciranna, and Mr. Tom Lopez, Chief Investment Officer. Commissioner Pendleton discussed investing in S&P Index or bond funds. Commissioner Salimpour requested that a detailed breakdown of management fees be included in the asset allocation report from staff. Commissioner Pendleton requested a study of Index Funds be included in the asset allocation report.

General Manager Ciranna stated that the Department is adding four new positions: one Management Assistant in the Administrative Services Section to work on special projects, one Benefits Specialist in the Communications and Education Section to increase seminars and outreach to members, one additional staff member in the Disability Pension Section to address the increase in disability pension applications, and a Chief Benefits Analyst in the Pensions Division.

Public comment was provided by Mr. Ken Buzzell, Los Angeles Retired Fire and Police Association, Inc., who discussed large cap, expenditures, and health care and Ms. Elsa Moy,

who discussed private equity partnership fees.

RESOLUTION 16110

Commissioner Navarro moved that the Board approve the Fiscal Year (FY) 2016-17 Proposed Budget and instruct staff to submit it to the City Administrative Officer (CAO) and the Mayor's Office for inclusion in the Mayor's FY 2016-17 Proposed Budget, which was seconded by Commissioner Salimpour and approved by the following vote: ayes, Commissioners Aliano, Diannitto, Nathanson, Navarro, Pendleton, Salimpour, Tapia, and President von Voigt – 8; nays, none.

6. REQUEST TO SUSPEND WORKERS' COMPENSATION RECAPTURE OF ANTHONY ESCOBAR, DISABILITY PENSIONER AND POSSIBLE BOARD ACTION

The board report was approved as submitted.

1. The annual Statement of Economic Interest Forms 700 and 60 are due by April 1, 2016 and are available online.
2. Announced that the Board, during their March 3, 2016 Board meeting while in closed session, approved initiation of litigation in Germany to pursue compensation claims against Volkswagen AG.


